The Benefits of Face-to-Face Meetings

From the President -Ken Olson



In the 10+ years that I have served on the IFOMPT Executive Committee (EC), we have been fortunate to have a face-to-face meeting each year. As my term as President began in July 2016, the IFOMPT EC was faced with a budget shortfall that forced us to re-evaluate the necessity of face-toface meetings due to the travel and lodging costs associated with these meetings. The feedback the EC has received from the Standards Committee (SC) is that face-to-face meetings are crucial to the productivity and communication within this committee as well.

Both the SC and EC utilise on-line teleconference platforms to meet at regular intervals throughout the year. In addition, much work and correspondence is carried out throughout the year via email and other electronic means. Likewise, the IFOMPT Advisory Groups and Taskforce meet via on-line platforms and with electronic communication. Although these communication avenues can help to move projects along, the face-to-face meetings seem to further facilitate the working relationships among the committee that results in enhancement and ease of communication with these other means through the rest of the year.

The depth and breadth of communication is much greater when meeting face-to- face due to learning

personalities of the committee members and their communication styles. Often, non-verbal communication is lost in the on-line formats and even the teleconferences. The nuances of language can be difficult to pick up when communicating by electronic means with committee members from varying cultures and language backgrounds. Additionally, the informal social interactions among committee members deepens the personal relationships between them that can further enhance the cooperation and productivity of the group into the future.

The EC has worked with the Advisory Group on Finance to develop strategies to improve the financial situation of IFOMPT over the past 2 years. In addition, our Executive Director, Ingrid du Toit, manages a very tight ship in how she runs the office to provide excellent membership services at a very reasonable cost. Ingrid was also instrumental in working with her family and local contacts in Cape Town to facilitate face-to-face meetings at a reasonable cost to stretch the IFOMPT dollars for 2017. In addition, several MOs stepped up to provide partial or full funding for members of the SC from their MOs including Denmark, Canada, and the UK. Some of the SC members have also been able to attain funding from their employers if they present papers at the conferences where the meetings are being held. I am thankful for all the support IFOMPT committee members have received to help us afford to have this face-to-face Interaction.

The trip to Reno in November 2018 was fully funded by the USA MO, AAOMPT. They provided a \$25,000 grant to IFOMPT to allow us to bring the SC and EC to their annual conference and provided meeting space and social engagements as they hosted us at their conference. In exchange, several EC and SC members provided presentations to enhance the AAOMPT conference offerings.

This also provided IFOMPT the opportunity to promote the benefits of IFOMPT membership to one of our largest MOs and to promote the IFOMPT 2020 Conference. We had representatives from 10 MOs and 2 RIGs at the conference allowing us to staff a booth in the exhibit hall and have an IFOMPT membership meeting.

therapists from around the world. It provides a platform to share scientific knowledge and to facilitate international interaction and networking, while it also operations of the IFOMPT activities and IFOMPT shall hold a conference at least every four years. Apart from prescribing that the Delegate Assembly will determine bidding process outlined in the Governance Manual and stating that it must include clinical and scientific sessions, the Constitution is silent on how the conference takes place. Although the Executive Committee has some oversight and has reports presented to them over the years leading up to the conference, it identified by previous organising committees as an issue that should be addressed for the future.

Paolo Sanzo (Treasurer, IFOMPT Executive Committee), Amy Fagan (MO Australia and Chair of the Advisory Group on Finance), and Bob Rowe (MO United States and member of Advisory Group on Finance) presented information generated from discussion with the MOs and RIGs along with feedback from the Executive Committee and various advisory groups regarding the possible modifications to the IFOMPT conference at the MO meeting in Reno. Some of the key ideas proposed included the increase in oversight by the Executive Committee of the conference and also considerations for a rotating regional model for future conference locations, the development of a future standing IFOMPT international conference organising committee, offering a conference on a more regular basis possibly every two years after 2024, and future changes in the bidding process and profit-sharing model.

Given the fact that the financial viability of IFOMPT depends on the conferences making a profit, it stands to reason that the IFOMPT Executive Committee needs to be more directly involved in this event. It is, therefore, proposed that the Executive Committee, in their capacity as the elected representatives of the members of IFOMPT and with their oversight and fiscal responsibility to IFOMPT, should be responsible for making the final decision on which MO hosts the conference. The proposed document for the Constitutional change:

1. Motion - To amend Article VII Section3) of the Constitution as follows:

"ARTICLE VII GENERAL AND SPECIAL MEETINGS SECTION 3) Conference

The Conference of the Federation, which shall include clinical and scientific sessions, shall be held at least every four years. The Delegate Assembly **Executive Committee** shall determine which Member Organisation shall hold the Federation Conference based on a bidding process outlined in the Governance Manual. Except as hereby varied the terms, covenants and provisions of the Constitution shall remain in full force and effect."

Members are requested to consider this proposed amendment and to provide comments and inputs to the office by 14 January 2019 after which the decision will be made to proceed to vote on the proposed amendment - Paolo Sanzo

The Standards Committee (SC) participated in the AAOMPT Conference in Reno in November 2018. Our thanks go to AAOMPT for their organisation and hospitality that enabled 2 days of very productive meetings with the EC, and a range of meetings with MOs and individual OMPTs. The SC ran 2 workshops during the conference: 1] Clinical mentorship and 2] Research component of standards, Alison delivered a keynote and Leanne a platform presentation. It was a successful meeting especially for the networking opportunities.

Key business covered by the SC during their meetings included an update on working group activities, international monitoring reviews and letters, evaluation of international monitoring, review of new MO applications from Cyprus and France, SC resources on the website, SC continuity planning. A key theme underlying the SC meetings was preparing for Ronel Jordaan to take on the role of Chair from 2020. Celebrating 50 years of excellence in musculoskeletal physiotherapy in the UK



This year the MACP, the UK member organisation for IFOMPT celebrated its 50th Anniversary at the Physio UK conference In Birmingham. The MACP delivered the musculoskeletal theme of the conference showcasing the progression of evidencebased practice in musculoskeletal treatment, clinical reasoning and service delivery. This included 18+ presenters and 4 key note presentations including clinical reasoning into practice, exercise specificity, neuropathic pain management, behaviors and beliefs in healthcare and a round table discussion on the development of first contact practitioner roles. The conference boasted 50+ musculoskeletal posters, rapid 5s and platform presentations for the scientific programme and was attended by >1200 delegates. The 'best PUK ever!' (CEO Chartered Society of Physiotherapy) was testament to the hard work of Organising Committee, led by Colette Ridehalgh and support from by the MACP Executive committee (some of whom are included in the photo below).



Our collaboration with the Chartered Society of Physiotherapy to lead the musculoskeletal theme reflects the reputation and standing of the MACP in UK physiotherapy healthcare. As for the past 50 years, the MACP has been at the forefront of musculoskeletal physiotherapy in the UK and pushing the boundaries of research, education and clinical practice.

At the conference, the MACP held its AGM where Fellowships were awarded to Laura Finucane, Neil Langridge and Sue Sriskandan. This year we also bid farewell to Terry Smith, our administrator for the past 17 years who has now retired.

The evening concluded with a drinks reception for MACP members past and present and invited guests to celebrate our 50th anniversary. The evening was opened with an address from Agneta Lando (former IFOMPT President) on the history of the organisation and its role in the development of UK musculoskeletal physiotherapy from its humble beginnings 50 years ago. From the early days of Greg Grieve, Dr James Cyriax, Jenny Hickling, Sue Adams and Geoff Maitland to the present day where the MACP continues to offer a unique professional development pathway and a strong voice for UK musculoskeletal physiotherapy -Uzo Ehiogu and Nicola Heneghan

With less than two years until the IFOMPT 2020 conference in Melbourne, Australia, the conference organising committee is pleased to announce that it has secured 2 International keynote speakers: Associate Professor Annina Schmid and Professor Deborah Falla.





Before commencing her research career Dr Schmid completed a Masters of Musculoskeletal Physiotherapy degree from IFOMPT recognised Curtin University's program in Perth, Western Australia. Well established as a musculoskeletal clinician, she wanted to do more for her patients and the models of care physiotherapists deliver. Now based at The University of Oxford, Annina's research focusses on advancing our understanding of the pathophysiology of compression neuropathies to ultimately improve management of these patients. In addition to her research activities, Dr Schmid teaches postgraduate courses related to pain and neuroscience internationally. She also maintains a weekly caseload as a specialist musculoskeletal Physiotherapist. Further information can be found at www.neuro-research.ch.

Australian-born Deborah Falla is an expert in rehabilitation science and musculoskeletal physiotherapy. Her research utilises state of the art electrophysiological measures to evaluate the control of human movement and how it is affected or adapted in response to various states including pain, injury, fatigue and training. Her research interests also include optimising the management of musculoskeletal conditions with a particular interest in neck pain, low back pain, whiplash and headache. Dr Falla is Chair in Rehabilitation Science and Physiotherapy and Director and Research Co-Lead, Centre of Precision Rehabilitation for Spinal Pain at the University of Birmingham.
