Position Overview:

The Scientific Committee are key committee members for IFOMPT 2028. The Scientific Committee will consist of 6 international researchers and clinician scientists. Each member will bring unique experience to complement the committee's expertise. These positions work collaboratively with the Scientific Chair to oversee the scientific program for the conference through 3 key areas of focus:

- Keynotes
- Focused Symposia
- Conference program of presentations e.g. platforms / posters

Four sub-committees (each chaired by members of the Scientific Committee) will report to the Scientific Chair:

- Conference Chairing
- Rapid Response
- Late Breaking
- Mentorship

The Scientific Committee through the Scientific Chair works closely and collaborates with the IFOMPT 2028 Executive and Operations Chair, relevant committee members, the Professional Conference Organizer (PCO) and EDI consultant; to ensure the event is contemporary,

scientifically robust and clinically relevant, high impact and aligned with the conference's mission and values in its content, presentation and delivery.

- Ensure keynotes are contemporary, impactful and present new research
- Ensure focused symposia are thought provoking, challenging and contemporary
- Ensure the conference scientific program is cutting edge and clinically relevant
- Ensure high quality chairing of all sessions within the scientific program
- Ensure a rapid response to all enquiries of the Scientific Committee
- Ensure contemporary and current research findings are presented through late breaking acceptance of abstracts
- Ensure a high-quality system of mentorship for early career researchers and new presenters
- Onsite IFOMPT 2028 conference support for session quality and chairing
- With an EDI lens
 - ensure that sessions are inclusive and reflective of varied perspectives and identities.
 - Ensure integration of content that addresses equity and inclusion in the physiotherapy profession in both the clinical and academic fields and captures the patient voice.

- Excellent communication and interpersonal skills
- Aligned with our mission statement and values including commitment to EDI
- Responsive to timelines and flexibility in schedule to accommodate meetings in different time zones

- Experience in scientific program planning.
