# 2020 - Adapting to Overcome

# From the President -Ken Olson



The plans to hold a virtual General Meeting (GM) are coming together, and we are ready to announce several important dates to allow delegates to begin to prepare.

The plan is to have three webinars to explain the constitutional changes and one webinar regarding updating the strategic plan. The GM will be split into two sessions with the first session on Oct 5/6 where we will vote on the Constitution, have Executive Committee (EC) elections, and vote on new Member Organisations (MO). The second session will be on Oct. 8/9 where we will finish all other GM business such as recognising outgoing committee members, announce the Maitland Award, and we will wrap up any unfinished business. The first GM session will be restricted to just voting MO delegates, the SC Chair, and EC members, and the second session will include additional individuals as appropriate. By breaking up the sessions, we hope to keep the length of each session down to 60-90 minutes.



The webinars for the Constitution will be moderated by Paolo Sanzo and I, along with other members of the Constitutional Review Task Force including Frederic Froment, Bob Rowe, and Annalie Basson, will participate as presenters to explain the rationale to support the suggested amendments. The dates for the webinars are June 11/12, July 9/10, and August 6/7. The timeframes for the webinars will be afternoon in North America and evening in Europe/South Africa and the following early morning for Asia/Australia/New Zealand. We encourage both the delegate and an alternate from each MO to attend the webinars. These will also be recorded and made available to the MOs.

The strategic planning webinar will take place on September 10/11 which will present the results of several rounds of consultations and input that the EC will seek from the delegates prior to the webinar. We have hired a consultant to guide this process and more details will follow in the near future.



The IFOMPT EC is committed to moving the organisation forward despite the challenges presented by the pandemic and the postponement of our 2020 conference. Please mark your calendars for these important dates so that we can conduct the important business of IFOMPT and set up the next EC to continue to move the organisation forward.

#### Constitutional Review -Paolo Sanzo



The IFOMPT Constitutional Review Task Force has completed its task of developing a draft version of the new and updated IFOMPT Constitution. The Task Force has met on 8 occasions over the course of several months and has completed a comprehensive line-by-line review of the articles.

They have attempted to integrate modern language and formatting and have inputted the valuable feedback that was provided from consultation with MOs and RIGs of IFOMPT and other stakeholders including members of WCPT.

Members have the opportunity to provide further feedback via webinars and electronic communication in the coming months. The planned interactive webinars will highlight the key changes made so that this discussion can occur prior to the GM. This process followed has attempted to be transparent, inclusive, and really take into the consideration the wishes of the members. Delegates are encouraged to actively engage and participate in the upcoming webinars and provide constructive feedback. By doing this collectively, we will successfully chart the course for the governance of IFOMPT into the future.

#### International Framework for Red Flags for Potential Serious Spinal Pathologies - Laura Finucane



In 2016 we embarked on a journey to deliver a framework on red flags, a request from you, our MOs. If you had asked me 4 years ago what it might look like, I along with the rest of the steering group would not have been able to tell you. What we did know was that identifying serious pathology of the spine was problematic and held concerns for clinicians. Despite the historical use of red flags, there was a paucity of evidence supporting their use, calling their use into question and a proposal to abandon them. Not a helpful position for clinicians faced with the everyday challenge of identifying serious pathology.

Four years on we have developed a framework which we hope will be useful in clinical practice. The framework has been informed by available evidence and strengthened by a formal consensus process that included academics and clinicians involved in the management of musculoskeletal conditions - it uses the evidence. Clinicians need to consider the context within which red flags exist and clinically reason the relevance of the information gathered to determine if any action is required.

Thank you to all of you who contributed to the framework, many of you either individually took part in the peer review or provided us with names of people who were keen to participate. We would also like to thank those MO's who supported the project financially.
